

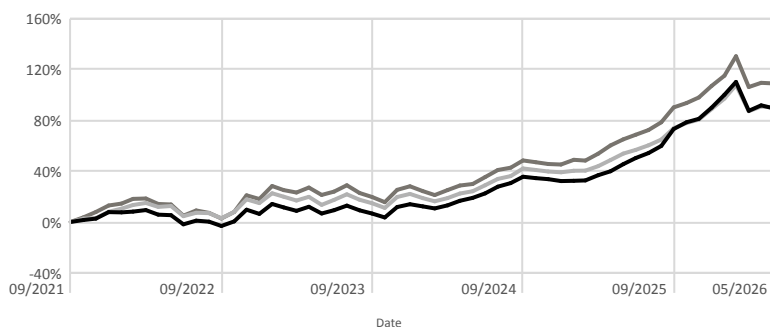
INVESTMENT OBJECTIVE

The Visio BCI SA Equity Fund is a domestic general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT POLICY

The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value. The portfolio's investment universe consists of domestic equity securities, preference shares, interest bearing securities, property shares and property related securities listed on exchanges and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes or other similar schemes registered in South Africa and which is consistent with the portfolio's primary objective. The portfolio may from time to time invest in listed and unlisted financial instruments.

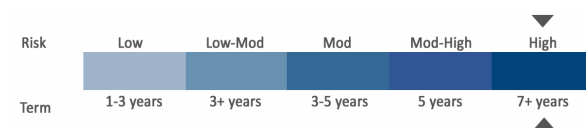

High Risk

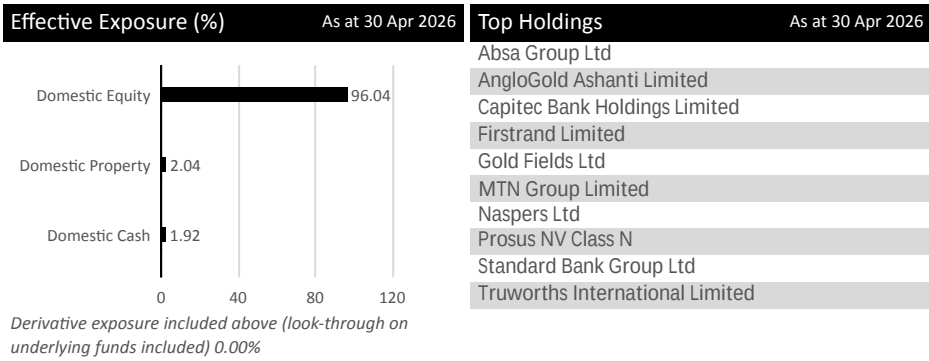
- This portfolio has a high exposure to equities and therefore tends to be more volatile than most other portfolios.
